1. Call meeting to order.

The RBWCCS PTO meeting was called to order at 5:49PM by Vice Chairperson Reshia Carson.

2. Board Report.

Board Meeting was cancelled: nothing of significance to be reported at the time of PTO meeting. Motion to accept was made by Benny Simmons and seconded by Anthony Williams. All in favor vote was sought and given unanimously.

3. Treasurer's Report

Treasurer's Report was given audibly by Bob Simpkins. Print out of report is attached. Motion to accept the Treasurer's Report as read with any necessary corrections was made by Anthony Williams and seconded by Angela Carr-Heidelberg. All in favor vote was sought and given unanimously.
